## RGT 25/13.2 Matters relating to sports clubs

Oli Plaistowe and Jan Macavoy from CHCC talked us through the revised plans regarding the pavilion refurb. They have approached the FA, ECB and Sport England for funding.

ECB have come back highlighting the new safeguarding aspects regarding changing rooms, toilets and use of pavilions by both girls and boys. Current changing rooms do not comply. Also requirement to improve disabled access. Walking cricket to be introduced in April. Both FA and ECB will work together regarding their funding. Proposing a storage unit 4m x 7m located behind the cricket nets. However this could cause issues with manhole covers and visibility from parts of Redhearn Fields. Storage is required as proposing to turn garage into changing rooms.

Cllr M Shorthose stated that parking would come under more pressure.

CHCC have had 200 responses to their survey and many have mentioned enhancing the community aspect of the pavilion by including a café for example.

Cllr Munro asked what their ideal timing was to start the planning process? Hope to put in application in end of the Spring with works starting in the Winter of 2025/6. Also looking into funding for irrigation works.

Jan Macavoy stated funding from SCC Community Fund is on a 'first come first served' basis. RGT will need to submit grant application.

Governing bodies of ECB and FA need a single point of contact.

Clerk to send updated plans to Charity Commission and speak to Mark Mulberry regarding the entire process.
