#### 25/16 Chairman's Welcome

Cllr 5 Shorthose welcomed all to the meeting.

## 25/17 Presentation from Ben Hapgood, Surrey Wildlife Trust

Looking into landowner engagement. Visited Wicket Wood to assess plans and opportunities for the environment and biodiversity. Focus on landscape scale and connectivity. 7 landowners already engaged in Churt, could be sizeable future funding.

'Land App' is a free software package which shows statutory designations. Wicket Wood is designated as common land meaning the public can walk across the whole area.

Funding considerations for Surrey Hills AONB. SSSI plus SAC and SPA on doorstep of Wicket Wood.

Most valuable habitat from a diversity perspective is lowland heathland. 3 main species to consider in relation to connectivity are adders, nightingales and grayling butterflies. Long term vision is therefore not to lose heathland as a priority habitat.

Enhancing woodland habitats ticks boxes for the Forestry Commission.

Consider how climate adaptive the environment is? Broadleaf species provide a fire break.

Therefore a reduction of conifers could lead to an increase in broadleaf species.

Ideal is to have 63% heathland habitat. Grants available to restore lowland heathland which costs £311 per hectare.

No stewardship funding available until the Summer.

We should consider a 10 year woodland management plan.

Cllrs Spence and Johnson to apply for some grant monies.

#### 25/18 5 minute presentation by SCC

Central government determined to reorganise local government. SCC to submit a response in the next 10 days to the latest suggestions. SCC have said no to adding in part of another County authority. Waverley should sit with Guildford and Mole Valley. Electorate need to be protected when their Council is not in debt, as per Waverley Vs Woking. Cllr Spence asked when would parishes be approached?

Elections will now be in 2026. Important to look after the local environment, there are 17 separate commons alone in the Western Villages.

## 25/19 5 minute presentation by WBC

Cllr Munro advised that the leaders of all Boroughs and Districts were getting together each week. Preferred option is for 2 or 3 unitaries. Decision will be made in Whitehall. Aim to be in place by 2027?

Regarding planning WBC have to apply the new NPPF guidelines, to date there have been no test cases for large scale development.

Cllr Harrison thanked Cllr Munro for the swift removal by WBC of fly tipped bins and a dead deer.

#### 25/24 Report from the Environment Committee incl. Farnborough (JS/MJ)

Farnborough Noise update in papers. Application still with Rushmoor. WBC will object again in March.

We have a management plan for Wicket Wood, propose to thin out pines and create glades. James Gray charges £650 per day for 2 men. Cllrs Spence and Johnson will apply for a grant of £4000 from SWT towards equipment. Need to submit application before the end of March. Will inform locals when works start.

Main herbicide for bracken can no longer be used.

Some local residents have been dumping cuttings in Wicket Wood. Clerk to request this practice stops.

Cllr Johnson advised that the Church have formed an eco church group to engage more widely in the community on environment matters.

The hedge between Old Kiln Close and Redhearn Fields has now been cleared.

The Environment Agency were advised about the diggers at Lowicks.
