Cllr Harrison asked for the 'dogs to be kept on a lead' sign to be replaced plus look into whether anything could be done where the bark was separating from the cedar bench. Cllr Harrison also asked if the ropes hanging from the tree in Hale house Close near the playground could be removed as they pose a risk for children playing on them.

The Wormwells at the top of the Rec have reported a tree near them as being dangerous. This will be reported in the arboriculturist's report if there is an issue.

RGT 24/34.1 Payments for authorisation - March 2024

RGT 24/35 Resurfacing of Hale House Close.

Cllr Shorthose reconfirmed the legal advice we have received that notwithstanding the lack of obligation to maintain the road according to the Deeds, the RGT does have occupier's liability. SALC solicitors advice is that it would be fair to place the greater burden for the cost of repairs on the residents.

We need to oversee the works and if we pay and then invoice the residents they will not have to pay the VAT element. Suggestion is we pay 20% and the 4 residents pay 20% each amounting to 100%.

Cllr Johnson stated that by us contributing we are taking our responsibility on board and are able to control the work.

Cllr Wright asked what would happen if the residents refused to pay? Cllr Johnson confirmed she has spoken to all 4 residents and they are happy to pay their share of the current works. Cllr 5 Shorthose proposed we adopt this suggestion, Cllr Johnson seconded, Cllr Martin abstained, all others in favour.

Cllr Johnson will speak to Grasstex to see when they can start the works.

There being no other business, the official meeting of the Churt Recreation Ground Trust closed at 9.20pm.
